 - a. **Drop-off bays for Leuchars Railway station** propose to accommodate 4 drop off spaces (20mins limited waiting) and 2 disabled parking spaces next to the motorcycle parking on the right hand side (overlooking Station Road) within the new car park comments requested by **9 October.**

- 4. Environment matters
 - **a. Brownfield site** Willie Rennie MSP wrote to the landowner of the wasteground at Old Eden Bridge
 - b. **Community Garden site vandalism near Motray walk**. I have raised the issue of the site with Scottish Water and am waiting on their response.

5. Housing matters

a. **Window replacements –** issues regarding the need for the replacement of some council house windows have been raised with the Housing Officer

6. Planning matters

- a. Fife Plan now adopted and replacing previous planning guidance see here "The policies in the Plan and supplementary guidance will be used to determine planning applications and give guidance to communities and investors on where development can and cannot take place, what type of development is allowed, how it should be laid out and designed and how environmental and cultural assets will be protected."
- b. Community centre the planning officers have made the following comment on the ambition to link this to the Persimmon development. "We cannot take contributions through s.75 for a community centre if there is no link to the development. There is no requirement within the LDP site policy for a community centre / monies to be provided. I would suggest that this is requested from the developer separately from the planning process through some type of community betterment."

7. Roads & Traffic matters

- a. Broken Bollard at the bottom of Cupar Road near the Dundee Road roundabout was reported
- **b.** Flashing Speed Sign continuing to chase this. We have been assured the equipment is on order but there is no set delivery date yet.
- c. Street nameplate signs were requested in March for Old St. Andrews Road, Cupar Road,, and Main Street. Only Cupar Road is on the list, however, with the others being refused. The most recent update was that the delay was the results of seeking economies by dealing with signs in a block – "before the end of the year"

8. Other news/issues

- a. North Fife Cycling 2nd meeting in Newport considered possible projects where funding might be sought to improve cycling infrastructure in North Fife, and awareness of cyclists; for example work to improve the core path at Drumoig for use by cyclists. There has been some awareness raising of the issue in the press see article
- b. District heating scheme Persimmon has provided an in principle letter of support to the University stating that subject to commercial considerations they would be willing to consider being part of the scheme for their housing development in Guardbridge. The University is in the early stages of making an application for grant support and are developing a business case for LICTP funding due by 31 March
- c. Eden Mill having only started in 2012 they now employ 52 staff and are exporting their products to over 20 different countries. In addition, the average age of their staff is under 30. Locally, as you may know, their product is stocked by Asda stores
- **d. Play facilities** Karen Scott, Community Education Worker, is beginning work with a group in Guardbridge wishing to upgrade play facilities. She will be supporting them to form a constituted committee, secure funding, and achieve youth awards.
